## ACTION 2: Cultivate the habit of filling in field reports this month.

Why are field reports important? Social capital can trump financial capital. As Cathy said previously, "I know many of you are wondering how you can help CCL Canada continue to thrive and save the planet. Politicians take note of highly organized grassroots groups. Please document your actions without us having to track you down to do it. This simple action, which for most takes under an hour a month, helps us immensely. Your social capital can trump the financial capital of those who would oppose the actions necessary for a liveable world."

**Don't know how to fill in field report?** There is lots of support. <u>Watch a tutorial video</u> (13 min) or look at <u>step-by-step notes</u>.

#### **Correcting Mistakes and Oversights**

If you discover you overlooked an activity that needed reporting, you can do it at any time. No report is too late to file! If you discover that you accidentally did a report twice or made a mistake on a report, please send an email explaining the error to fieldreports@citizensclimate.org. Include the email confirmation for the report in your email to make it easier to find the right field report to fix.

#### How to fill in a CCL field report:

- 1. Assign someone in your group to do it.
- 2. Ask that person to cultivate the habit of doing it. Some people find it helpful to enter field reports as they arrive. Others like to set aside a certain time every month to do it during CCL Busy Week.
- 3. Go here: <u>https://community.citizensclimatelobby.org/field-reports/</u>
- 4. You must have a CCL Community Account. If you do not have one or lost your password, use the communications box on the bottom of the page to get one.
- 5. Note all field reports are confidential and stored in a highly secured database.

#### Fill in the report.

Field reports let you and the national office track our activity, for our own development and to share with supporters, parliamentarians, and funders. More directions are on the field report form.

#### Types of actions to report:

a. Meetings with legislators or their staff, editorial boards, and asking a question at a Town Hall event.

b. Published media, letters to editor, editorials, op-eds, articles, online media, TV, Radio.

c. Outreach including tabling or presentations at events, and educational presentations and getting organizations and cities to sign our Open Letter.

d. Personal Letters to members of Parliament Report the total number of letters, constituent comments or emails to members of Parliament and Senators (not emails to staff) for the month. This includes the February 2018 actions:

e. Social Media Interactions with Parliamentarians: You can count and report social media interactions with MPs,senators, ministers, premiers, MLAs, MHAs, MPPs and city representatives. Please prioritize your communications with your local MPs because "all politics is local". The next priorities would be your Premier and

the Environment Ministers (provincial and federal). All political leadership matters. Thus leveraging support from other politicians will be counted too.

#### What do we do with them?

We report the numbers to empower our MPs, our volunteers, and our supporters. Next time you meet with your MP, be sure to tell her/him that CCL Canada appeared on the editorial pages of Canadian newspapers 589 times in 2018 and had 14% of all print media hits globally within Citizens' Climate Lobby. In 2017, CCL Canada had 701 media hits. In 2016, we focused on lobbying. Again, check out what happens when you inform a member of another environment group or an MP unfamiliar with CCL that we recorded 199 lobbying sessions in 2016.

For lobbying notes - it is really critical to record your notes for our future reference.

Why send lobby reports to us?

i. We only report lobbying sessions numbers that have been officially recorded. Your teamwork empowers everyone across Canada and the world.

ii. If you lose your lobbying notes, we can quickly retrieve it and send them to you when you need them.

iii. The national office reads the lobby notes as well as receives many oral reports. We trust our volunteers will follow through on any actions they promised to MPs.

iv. We treat these notes as highly confidential and take security and privacy matters seriously.

## LASER TALK: THE MANY WAYS TO PRICE CARBON

Our governments have 6 basic options to confront climate change. They are listed from least transparent to most transparent:

1. The status quo – Our whole society finances fossil fuels – most expensive option by far.

**2. Regulation** – boots on the ground, eyes on emissions. This approach requires the government to hire regulators to keep tabs on everyone's emissions and is dependent on the budget for enforcement. This approach is only as effective as the number of sources it can monitor, but hiring regulators is expensive, so it will only catch the largest carbon emitting companies, not your car or your neighbour's lawnmower or your friend's boat.

**3. Cap and Trade** – creates an artificial market. It involves putting a cap on emissions, but lets companies trade the emissions they produce. It still requires hiring regulators to tell us who is emitting how much (and all the problems that come with regulations) and creates a market where a select few people make money and the rest of us are left with a fluctuating fuel market

**4. Subsidies** – government picks winners and losers. It can be really hard to predict the future and what will be the best option down the line. We know how this has failed us in the past when the government decided to subsidize fossil fuels.

5. Carbon Tax – a sin tax that puts pressure on consumers. The positive is that carbon taxes are highly effective at reducing carbon emissions because they hold companies monetarily accountable for the negative consequences of the emissions they use, and , if the tax is put at the source (such as the coal mine or the oil refinery) they don't require many regulators. The downside is that, with just a tax on carbon emissions, companies will push the extra cost off to consumers and make all products more expensive. When things get more expensive, people won't be able to afford as much so it will slow down our GDP growth and economy.

6. **Carbon Fee and Dividend –** This is CCL's preferred solution. It is simple and effective. Carbon fee and dividend includes a fee on carbon emissions at the source, then the revenues from that fee go back to households – It's this dividend that grows the economy and protects the most vulnerable.

<u>Quebec</u>, <u>California</u> and the <u>European Union</u> are jurisdictions that have implemented cap and trade with offsets to mitigate their greenhouse gas emissions.

British Columbia, Alberta, Norway and Sweden have carbon taxes.

On Tuesday, October 23, 2018, Prime Minister Trudeau <u>announced</u>. Canada's carbon fee revenue returned to households will be called a <u>Climate Action Incentive</u>. And thus, Canada became the first country in the world to enact a carbon fee and dividend policy.
