

Lobbying and Advocacy

National Conference

CCL Canada's spring 2024 national conference and lobby days, "Dream No Small Dreams," took place in Ottawa from June 2-4. Seniors for Climate Action Now! Ottawa and the Canadian Association of Physicians for the Environment were co-hosts, making this our first national conference to be hosted in collaboration with partner organizations. The conference yielded 25 lobby meetings with MPs, and members will continue to meet with their MPs in the ridings throughout the summer. The conference featured a keynote address from the Honourable Catherine McKenna, Canada's former Minister of the Environment and Climate Change. On CCL's role in putting a price on carbon in Canada, McKenna said, "You guys were amazing, because it was really important to show that this was something that had broad public support ... We needed people to actually speak up and say this is what we want, and this is good for people." MP Adam van Koeverden also recognized CCL Canada's efforts by mentioning us during Question Period in the House of Commons. A series of "Celebrate the Rebate" Instagram reels that we made on Parliament Hill during the conference have accumulated over 49,000 views.

Lobbying Event in Manitoba

On April 4, close to **40 Manitobans** gathered for a breakfast event at the provincial legislature. The event was attended by **18 MLAs** (or their staff). **Co-hosts for the event** were MLA Mike Moroz, CAPE (Canadian Association of Physicians for the Environment) Manitoba, CANE (Canadian Association of Nurses for the Environment) Manitoba, For Our Kids Manitoba, Manitoba Energy Justice Coalition, and Re-Generation. The two main lobbying asks were for Manitoba to fulfill their role in the Pan-Canadian Framework on Climate Change and for Manitoba to sign on as a friend of the Beyond Oil and Gas Alliance. Mother's Day Event in Ontario

On May 6, in the lead-up to Mother's Day, CCL Ontario joined forces with CAPE (Canadian Association of Physicians for the Environment) Ontario, For Our Kids Toronto, Toronto East Residents for Renewable Energy, and Seniors for Climate Action Now to **speak out against** the Ontario government's planned expansion of **fossil gas infrastructure** for electricity generation. The event was **youth-focused** and featured a press conference co-hosted by the Green Party of Ontario, with remarks by Party Leader Mike Schreiner, medical student Grace Kuang, 11-year-old climate activist Robert, and CCL Canada Deputy Project Manager Mary Blake Rose. Attendees included an infant and three other youth under the age of 12, and some had travelled from as far away as North Bay, Ontario. Signatures on a Carbon Pricing Petition

Canadian volunteers helped generate a fair share of the **1492 signatures** on a House of Commons petition urging legislators "to fully support the planned increase to the Federal Carbon Tax in April of 2024 and to **renew their commitment to current Federal Carbon Tax legislation** for the good of all Canadians." This petition was not initiated by CCL Canada, but we chose to help gather signatures because its message is so close to our work. Images that we posted on social media during this campaign were shared hundreds of times, with no paid advertising.

Crashing an Axe the Tax Rally

An increase in the federal fuel charge came into effect on April 1, bringing with it a series of "Axe the Tax" rallies from opponents of Canada's price on carbon. Our National Director Cathy Orlando attended one such rally as a **solo counterprotester** holding a **"Carbon pricing makes my life more affordable"** sign. It is uncomfortable to do such things, but at this time in history, there is no time for nonsense and we must stand up against it in real time. Read more here. Within two weeks of this incident, the giant "Axe the Tax" billboard in Cathy's community was taken down. Her experience was broadcast across Climate Action Network Canada, yielding massive appreciation. In a more recent "Axe the Tax" tour, Sudbury was the only city where the event was not referred to as "Axe the Tax," but instead was called "An evening with Pierre Poilievre in support of the Conservative Party of Canada."

ENVI Committee: National Flood and Drought Strategy

On April 9, National Director Cathy Orlando and Caterina Lindman, leader of CCL's Waterloo Region group, presented to the House of Commons Standing Committee on Environment and Sustainable Development (the ENVI Committee) regarding Bill C-317, *An Act to establish a national strategy respecting flood and drought forecasting.* Canada is currently the only G7 country that does not have a national flood and drought strategy, and that is a concern, given that the world is becoming uninsurable. The presentation drew on Cathy and Caterina's personal experiences with the effects of precipitation and drought, and on Caterina's professional expertise as a retired actuary. ENVI Committee: Cap on Emissions

On June 6, the National Director was a witness in the room when Canada's major oil companies were grilled by the ENVI Committee regarding the Cap on Emissions. Alongside six other climate-impacted Canadians, Cathy met with five MPs to relay her story. She drew on her personal experience with the direct effects of climate change; several years ago, her house was condemned after the internal structure of her roof had catastrophic failure following extreme snowfall. 
Mentions in the House of Commons

We generate political will by **building relationships**. One way we can see that our relationship-building is working is **when MPs mention us** in the House. On June 7, the day after our National Director was a witness in the room when Canada's major oil companies were grilled by the ENVI Committee regarding the **Cap on Emissions**, NDP Environment Critic Laurel Collins drew on the climate impact stories of Cathy Orlando and others in a question about strengthening the emissions cap. In his answer, the Minister of the Environment's Parliamentary Secretary Adam van Koeverden thanked Citizens' Climate Lobby Canada for our advocacy.

Communications and Informational Resources

Connecting on Social Media

CCL Canada continues to connect with members, our elected officials, and the community at large through social media. In Q2 of 2024, compared to Q1 of 2024, our Facebook account has seen the following increases: net new followers are up 90.7%, page visits are up 174.9%, and reach is up 405.7%. On our Instagram account, we have made more posts in the second quarter of 2024 than we had made in all of 2023. A series of "Celebrate the Rebate" Instagram reels that we made at our national conference on Parliament Hill have accumulated over 49,000 views. This quarter, we have also published 588 tweets and retweets (replies not included), 81 posts on Threads, and 60 posts on Bluesky. A very important tool for building political will in our communities is **engaging with local and national media outlets** through letters to the editor and OpEds, as well as radio and television. In total, from the beginning of January through the end of June, CCL members have connected with and/or appeared in the mainstream media **449 times**. While there is not space here to share every success story, here are a few highlights.


CCL Canada co-founder Cheryl McNamara of Toronto, Ontario opened the month of April with a piece in the *National Observer* about how Canadians may come to appreciate our price on carbon if it is taken away. Circa Earth Day, Donna Freedman in Milton, Ontario had an OpEd published in *Milton Today* calling on Canadians to celebrate the carbon rebate. CCL Canada co-founder Gerry Labelle had an OpEd published on the same topic in the *St. John's Telegram.* Labelle's piece was published in English and French, and was our first OpEd published in Newfoundland. Andy Kubrin of Calgary, Alberta had an opinion piece published in the *National Observer* in May called "Now is the time to defend carbon pricing." In June, Mary Blake Rose of London, Ontario, one of CCL Canada's Deputy Project Managers, was interviewed in French by Radio-Canada's Marie Villeneuve.

Informational Resources on Our Website

CCL Canada's website contains a wealth of information and resources for volunteers and anyone interested in learning about effective climate solutions. We continue to build our collection of laser talks, short but informative write-ups on specific climate-related topics. We've recently added two laser talk compilations; "Seven Lucky Laser Talks" was added in early April and "Spring 2024 Laser Talks" was added in advance of our national conference. We also continue to update our laser talks in light of recent events and as new information becomes available. For example, the laser talks "Carbon Pricing Works" and "Our Rights and a Liveable World" have recently been updated. Other informational resources on our website include recent media releases such as this one sent in response to the early season uptick in wildfires, and recordings from our national conference.

Volunteer Handbook



Member Spotlight: Sophia Mathur

In April, 17-year-old Sophia Mathur was featured in the *Maclean's* 2024 Power List. The profile, written by Katie Underwood, describes Mathur as Canada's **"No. 1 climate crusader."** Mathur is the youngest daughter of CCL Canada's National Director Cathy Orlando, and had her start as a climate activist at a very young age, attending **lobby meetings with MPs as early as 7 years old**. In 2018, at age 11, Mathur became the first person outside of Europe to organize a school strike as part of Greta Thunberg's **Fridays for Future** movement. In November 2019, Mathur made history as a plaintiff in *Mathur et al.*, a **youth-led climate lawsuit** filed against the Ford government in Ontario. 
Organizational Development

Master Plan to Election 2025 and Beyond

We have finalized our **master plan for election 2025 and beyond**, which was done through three meetings (in October, January, and again in June) and ongoing consultation with our volunteers. The master plan is dynamic because we await the results of the US elections and the UN climate negotiations in November before we can finalize what we are doing in 2025. We have, however, confirmed that our national conference in Ottawa will take place April 27–29, 2025. The Plan is informed by advice volunteers give us, as well as what we learn from lobbying.




CCL Canada's road ahead through 2025

Fundraising

We are humbled and grateful to have received the **highest ever amount in donations** from members in our Earth Hour to Earth Day fundraiser this year, approximately \$13,500. As always, we are accepting donations and appreciate any help that you are able to provide. Our major 2025 donation drive will happen from **Valentine's Day to Easter**, in the lead-up to our **biggest conference ever** from April 27–29. Our new goal is to be able to provide funding to conference attendees who wouldn't otherwise be able to come.

Building on 2023

CCL Canada takes pride in our successes from previous years and looks to build continually on these successes. 2024 has been going very well in this regard. CCL Canada volunteers submit field reports when they complete actions to build political will, such as meeting with an MP or writing a letter to the editor. These field reports generate metrics, which we can compile to track our progress. In all categories except for "Contact with Legislator,"¹ our metrics from the first half of 2024 (H1 2024) equal or exceed our metrics from all of 2023. This means that we are on pace to increase these metrics by more than 100%. Here is a comparison of our numbers from H1 2024 compared to the entirety of 2023 in six key categories.



¹ We conducted an extensive online campaign in November 2023, which generated a large number of emails to elected officials, leading to very high "Contact with Legislator" numbers for this particular month.
